



## **Eqcu'Eqo o wplw{ 'Eqngi g'Fkmt lev Citizens' Oversight Committee Application Form**

### **About Measures O 'and Eqcu'Eqo o wplw{ 'Eqngi g'Fkmt lev:**

Measure M, a \$698 million general obligation bond designed to address the evolving educational needs of local students and the broader community will enable the District to modernize and upgrade facilities across its three colleges, ensuring students have access to safe, state-of-the-art learning environments. In addition to infrastructure improvements, Measure M establishes a \$60 million endowment fund dedicated to long-term building systems and technology enhancements, allowing the District to remain responsive to future academic and workforce demands. Approved under California's Proposition 39, Measure M includes strict accountability provisions. As required by law, the Board of Trustees will appoint members of the community to a Citizens' Oversight Committee ("Committee"). This independent body will monitor the expenditure of bond funds, ensuring transparency and fiscal responsibility.

### **Qualifications and Term:**

The Committee shall consist of nine members, each of whom serves a two-year term, for no more than three consecutive terms, without compensation. Committee members must be at least 18 years of age, and represent one of the following groups: (a) one student who is currently enrolled and involved in student government or a similar group; (b) in a business organization representing the business community located in the District; (c) one person active in a senior citizen's organization; (d) one person active in a bona-fide taxpayers' association; (e) one person active in a support organization for with one or more colleges in the District (e.g., Foundation); and (f) four persons from the community-at-large.

**Committee members may not be an employee, official of the District, vendor, contractor or consultant of the District.**

### **Duties and Responsibilities:**

Committee members will review expenditure reports to ensure that (a) Bond proceeds are expended only for the purposes set forth in the respective ballot measure; and (b) no Bond proceeds are used for any teacher or administrative salaries or other operating expenses of the District. The Committee will also receive and review the annual performance and financial audits conducted for Measure M. Committee members are expected to attend regularly scheduled meetings and approve the annual report describing the progress made on Measure M along with the activities conducted by the Committee. The annual report is provided to the Board of Trustees and the community.

### **Application Process:**

Any person interested in being appointed to the Coast Community College District Citizens' Oversight Committee is asked to submit a completed application form which includes a summary of qualifications and explanation of interest in serving on the committee.
