1. Authorization to Purchase Office Furniture for Coastline Community College, Contract Military Education Department, Using the National Joint Powers Alliance Bid No. 011707

Public Contract Code 20652 provides authority for the governing board of any community college district without advertising for bid, the use of other public agencies contracts for the lease or purchase of equipment when the board has determined it to be in the best interest of the district. The furniture selected for several areas of the Contract Military Education Department located on the third floor of the College Center is compliant with the Coastline furniture standards. The college has selected Tangram Interiors, Contract No. 07Z00478/ NJPA 011707 utilizing the National Joint Powers Alliance contract to provide the furniture. After review by the Vice President of Administrative

Services, the College President and the Vice-Chancellor of Administrative Services, it is recommended that the Board of Trustees authorize purchase orders for the furniture using the above volume contract for the Coastline Community College's Military Contract Education Department.

Fiscal Impact: No General Fund Expenditures. NTE \$560,941.32 from Contract Education Ancillary funds.

2. Recommendation for Rejection of Claim for Damages against Coast Community College District for Personal Injury

The District Risk Services office received a Claim for Damages on January 23, 2008, against the Coast Community College District. The claimant alleges suffering personal injury when she tripped and fell while walking through the parking lot at Orange Coast College on or about August 27, 2007. The claimant alleges defective lighting in the parking lot where she tripped and fell. Claimant's attorney states exact damages are in excess of \$25,000.00.

The District's third party administrator, Keenan and Associates, has reviewed the claim and concurs with Risk Services recommendation that the claim be rejected in order to shorten the statute for claimant to file a court action.

It is recommended by the Chancellor that responsibility in this matter be denied and the Claim for Damages be rejected.

3. Bid Tabulation and Award of Contract to Hewlett-Packard for the District Data Center Relocation Services; Bid No. 1945

Notices were published on January 11, 2008 and January 18, 2008 in a local newspaper. Seven (7) bids were mailed to prospective bidders and two (2) bids were received.

Bids were opened on February 4, 2008 for the District Data Center Relocation; Bid No. 1945. The results are shown below:

1. System Maintenance Services. \$65,236.00 2810 S. 24th St., Suite 103, Phoenix, AZ 85034

2. Hewlett-Packard \$103,220.00 8356 W. Staghorn Dr., Peoria, AZ 85383

After review by the Purchasing Director and key DIS personnel, it is determined that Hewlett Packard is the only qualified bid. The dollar value of our Hewlett Packard equipment, which is the core of our Banner system, is approximately \$1.5 million, or half of the total equipment value of the move. Hewlett Packard is contracting with our other manufacturers such as Dell and EMC to ensure that our systems are up and running without a lapse in our warranties.

The System Maintenance Services bid contained no assurance from the equipment manufacturers that they are authorized to move the equipment and maintain our warranties without a lapse in coverage. The SMS bid did not include travel expenses, additional insurance, and other spending approvals. The timeline proposed by SMS for the move of the equipment was inadequate. The proposal was to

divide our equipment into three (3) arbitrary categories (non-mission critical, mission critical, and remaining equipment) and move the equipment on three (3) separate occasions. This demonstrated that SMS does not understand the scope or magnitude of the move, since all of these items are intertwined and must be done simultaneously.

After review by the Director of Purchasing and the Vice Chancellor of Administrative Services, it is recommended that in the best interest of the District, a contract be awarded to Hewlett Packard as the lowest qualified bidder and that the Vice Chancellor of Administrative Services or the Director of Purchasing be authorized to sign the contract documents.

Fiscal Impact: \$103,220.00 (General Obligation Bond)

Policy Implementation

1. Adopt Proposed Policy Revisions Relating to Acceptable Use of Computer and Electronic Resource Systems (Policy 050-1-6.2)

Given the mission-critical nature of technology and the District's increasing support of access to technology as a meaningful tool for staff and student use, it is necessary to put structures in place to protect the integrity and viability of technology systems for all users. Toward that end, it is recommended by the Chancellor that the Board of Trustees adopt the proposed revision to the Computer and Electronic Resources Systems Acceptable Use Policy to safeguard the District's electronic resources.

The Policy initially proposed and presented to the Board during its Regular Meeting of June 20, 2007 (see the language with the strikethrough) was discussed with all District constituency groups. Based on feedback, the original Policy was modified and presented again during the Regular Meetings of October 3, 2007 and November 7, 2007. After much discussion, the District also entered into Negotiations with all three employee representative groups to negotiate the impact of the proposed Policy. Based on those Negotiations, the Policy was completely revised to reflect the interests previously expressed by the Board and the District's constituencies, while also providing greater clarity, protections of individual rights, and improvements in the overall tone and language.

The Board reviewed the proposed policy revisions at the February 6, 2008 meeting. (The Negotiated Procedures are attached to each Trustee's Agenda for information. See attachment 7))

GENERAL PERSONNEL POLICIES

COMPUTER AND ELECTRONIC RESOURCES SYSTEMS ACCEPTABLE USE POLICY

The Coast Community College District owns, leases, and operates computer and electronic communication systems in support of the District's mission of providing instruction and support services to students, faculty, staff, community members and management personnel in support of education, research, academic development, and administrative functions of the District.

Access to computer and electronic information resources is essential to the working environment within the Coast Community College District. Use of computer systems and electronic resources for activities that include, but are not limited to, accessing and transmitting information for illegal, commercial, or pornographic purposes use is considered unacceptable use and is strictly prohibited. Unacceptable use is prohibited and may be justified grounds for loss of access to computer and electronic information resources, as well as disciplinary sanction and/or legal action as provided by Federal, State, and local regulations.

The Chancellor or designee shall be authorized to establish regulations for the implementation of this Policy to ensure acceptable use of District computer systems and electronic resources.

<u>Violations of this Policy and related regulations will be dealt with in the same manner as violations of other District policies or regulations and may result in disciplinary action. The full range of disciplinary action is available including the loss of computer use privileges, dismissal from the District or college, and legal action. Violations of this Policy may constitute a criminal offense.</u>

The Coast Community College District ("District") owns, leases, and/or operates a variety of computer and communication systems, including but not limited to, voicemail, electronic mail (e-mail), telephone, and access to the internet, which are provided for the use of District faculty, administrators, staff, and students in support of the programs of the colleges and District. Hereinafter, this system and all of its component parts shall be referred to as the "District Network." This network establishes a communications platform that often substitutes for in-person meetings regarding District business.

This Policy applies to all members of the District community using the District Network including faculty, administrators, staff, students, independent contractors, and authorized guests. The Policy covers the use of all District computer equipment and communication systems in computer labs, classrooms, offices, libraries, and the use of the District equipment, servers, systems, and networks from any location. If any provision of this policy is found to be legally invalid it shall not affect the other provisions of the policy as long as they can be effective without the invalid provision.

Ownership Rights

This Policy is based upon and shall be interpreted according to the following fundamental principle: the entire District Network, and all hardware and software components with it, is the sole property of the District which sets the terms and conditions of its use consistent with the law. Except as provided in Board Policy or collective bargaining agreements pertaining to intellectual property rights, employees and students have no rights of ownership to these systems or to the information they contain by virtue of their use of all or any portion of the District Network.

Privacy Interests

The District recognizes the privacy interests of faculty and staff and their rights to freedom of speech, shared governance, and academic freedom, as well as their rights to engage in protected union and concerted activity. However, both the nature of electronic communication and the public character of District business make electronic communication less private than many users anticipate, and may be subject to public disclosure. In addition, the District Network can be subject to authorized and unauthorized access by both internal and external users. For these reasons, there are virtually no online activities or services that guarantee an absolute right of privacy, and therefore the District Network is not to be relied upon as confidential or private. Nonetheless, the District seeks to afford email communications privacy protections comparable to those it traditionally affords paper mail and fax communications, consistent with State and Federal statutes. The District will also provide voice mail protection to the extent required by the Federal Wiretap Act.

District Rights

System administrators may access user files or suspend serviced they manage without notice only: (1) to protect the integrity of computer systems; (2) under time-dependent, critical operational circumstances; (3) as required by and consistent with the law; or (4) where evidence exists that violations of law or District Policy or Procedures have occurred. For example, system administrators, following organizational guidelines, may access or examine individual files or accounts based on evidence that they have been corrupted or damaged or subject to unauthorized use or misuse. In such cases of access without notice, data or information acquired may be used to initiate or extend an investigation related to the initial cause or as required by law or Board policy and/or to protect system integrity.

User Rights

While the District monitors electronic usage as part of its normal network operating procedures, the District does not routinely inspect or monitor users' computer hardware or files, email, and/or telephone message system, nor disclose information created or stored in such media without the user's consent. The District shall attempt to notify users before accessing computer hardware and files or prior to suspending service. In the event that the District acts without user consent, under its District Rights specified above, the District shall do so with the least perusal of contents and the least

action necessary to resolve the immediate situation. When the District accesses files without user consent, it shall notify the user as soon as possible of its access and provide the reason for its action.

User Responsibilities

The Board recognizes that computers and networks can provide access to resources on and off campus, as well as the ability to communicate with other users worldwide. Such open access is a privilege and requires that individual users act responsibly. Users must respect the rights of other users, respect the integrity of the systems and related physical resources and observe all relevant law, regulations and contractual obligations.

For District employees, the intended uses of the District Network are those which are reasonable and necessary for the pursuit of job duties; for students, the intended uses are those which are reasonable and necessary for the pursuit of instructional activities.

Although personal use is not an intended use, the District recognizes that the Network will be used for incidental personal activities provided that such use is within reason and provided that such usage is ordinarily on an employee's own time, is occasional, and does not interfere with or burden the District's operation, and not otherwise contrary to District policies or procedures.

"Unauthorized uses" include prohibited uses and any other use for a prohibited purpose, including illegal activities, messages which may constitute discrimination or harassment under state or federal law or anything that interferes with the intended use. These types of prohibited uses and purposes are further defined in the attached Administrative Procedures.

All users of the District Network must read, understand, and comply with this Policy as well as the accompanying Administrative Procedures, and any additional guidelines established by the District. Such guidelines will be reviewed by the District and may become subject to Board approval as a District policy or procedure. By using any part of the District Network, users agree that they will comply with this Policy.

Enforcement of the Policy

The Board directs the Chancellor or designee to enforce all existing federal and state laws and District and college policies, including not only those laws and regulations that are specific to computers and networks but also those that apply generally to personal conduct. Violations of this Policy will be dealt with in the same manner as violations of other District policies or standards of behavior and may result in disciplinary action, subject to applicable due process requirements. Such violations may be subject to appropriate personnel action and/or criminal investigation.

Users who believe this policy has been misinterpreted or misapplied may file a complaint in accordance with the Complaint Procedures found in the accompanying Administrative Procedures.

Students who do not observe the requirements of this Policy may be in violation of the Student Code of Conduct and subject to student discipline.

This Policy and Administrative Procedures shall be distributed to all new and existing employees. Nothing in this policy should be construed to interfere with First Amendment rights or with the academic freedom of faculty.
