#11 A leader who will build an exemplary executive team and work in collaboration and partnership with the College Presidents;

#12 A leader who has demonstrated accreditation experiences and has led one or more colleges through a successful accreditation process;

#16 A leader who can work effectively with a governing board, and can lead the District with confidence and distinction.
