2.02 DIS - Next Issuance 2012 General Obligation Bonds, Series 2017D&E

Vice Chancellor of Finance and Administrative Services, Dr. Andy Dunn, and Ms. Laura Franke of PFM Financial Advisors provided an overview of the Next Issuance 2012 General Obligation Bonds, Series 2017E&E, and responded to Trustees' questions.

In November of 2012, the voters approved Measure M, a \$698 million General Obligation Bond Measure. The bond was first issued in the form of Series A (\$190 million in tax exempt bonds) and Series B (\$10 million in taxable bonds to begin to construct an endowment), both of which were issued by Board adoption of a resolution in May 2013. At the June 15, 2016 meeting of the Board of Trustees, the Board adopted a resolution to issue Series C of the bond, in the amount of \$30 million. This board agenda item informed the Board of the planned 2017D & E issuance in an amount not to exceed \$340 million. At a future Board meeting, documents to authorize this bond issuance would be submitted for approval by Board Resolution. The Board requested that a list of projects for each campus by provided prior to the February 15th Board Meeting.
