Board President Grant opened the Public Hearing at 5:07 p.m.

Alexandra Le, Richard Armendariz, Lee Gordon, Libby Frolichman and Phu Do Nguyen addressed the Board during public testimony. Ms. Le voiced her support of a change to the composition of the Board to a seven member Board to reflect the diversity and richness of the student body and communities served. Mr. Armendariz acknowledged the Board for their achievements and the Measure M building projects, and indicated his support of the previously passed resolution to increase the Board from five members to seven members, stating he felt it would be better to do it now than wait until a later time. Mr. Gordon thanked the Board for investigating the proposal for by-trustee area elections. He indicated that he felt the chance that each constituent's voice would be heard was greater in smaller constituency areas. Ms. Frolichman voiced her support of transitioning to a by-trustee area method of elections and increasing the number of Board Members to seven to allow for better participation and representation of all communities within the district. Mr. Nguyen also expressed his support of increasing the number of Board Members from five to seven as he felt this would provide representation on the Board for the Vietnamese American student population.

Trustees thanked the public for their comments, again indicating that they were listening and were very interested in their opinions.

21.01 OCC – Non-Standard Master Services Agreement with Civitas Learning, Inc.


