As Cal/OSHA amended its regulation on June 17, 2021, it was recommended that effective immediately only unvaccinated employees should wear face coverings, and would be provided with respiratory masks upon request. Vaccinated individuals would not need to wear a face covering except under certain conditions as outlined by Cal/OSHA. Further, all those who wished to wear a face covering should be able to do so without risk of bullying or harassment.
