IV. Approval of Minutes of March 13, 2012 Board of Directors Meeting

V. Availability of Funds

Chair Cline explained to the members of the Enterprise Corporation, that item #5 dealt with the Enterprise having a financial availability of funds and there being a possible \$100,000 distribution.

Dr. Rich Pagel walked the members of the Enterprise Corporation through the Interim Statement of Net Assets for the Period Ending March 31, 2012. He stated the Retained Earnings for Orange Coast College as \$782,953 and Golden West College as \$300,603 for a total of \$1,083,557. Dr. Pagel further shared, that of these retained earnings, each of the two colleges would like to contribute \$75,000 towards a Bond Measure for the Exploratory Phase. Dr. Pagel explained the reason for having retained earnings as having a back up for any unforeseen expenses, which he recommends as 10% of gross.

Dr. Pagel reminded the group of the Orange Coast College restroom project which is anticipated to cost \$550,000 and will begin work next spring with Architects Bundy Finkel. Dr. Pagel explained that this project cannot be delayed due to Orange County Health Department requirements.

VI. Dividend Distribution to Shareholders Concerning a Bond Measure for the November 2012 Elections

On a motion by Ms. Hilgendorf and seconded by Mr. Yokoyama, the Board of Directors voted 7-0 to declare dividend distribution to each Shareholder for the amount of \$75,000 for the purpose of exploratory information campaign and to petition the Shareholders of the District Foundation to direct those funds to the District.
