3. Opportunity for Public Comment

5. Review, Discuss, and Possible Action Regarding Internal Audit Quarterly Update

Ms. Rachel Snell, District Director of Internal Audit, provided an internal audit quarterly update for the committee. Ms. Snell commented on the following topics:

- The development of an ethics survey (for vendors, staff and management) and an employee reference guide for the Enterprise Corporation, that hopefully would be completed within 2-3 weeks.
- A conference at the children's center had been scheduled for August 2020.
- PCI compliance meetings with the vendors were continuing to be held virtually.

Ms. Snell also shared a memo that had been sent to the Chancellor offering a list of budget savings suggestions.

6. Review discuss and possible action regarding proposed budget

Chancellor Weispfenning offered a few words concerning the watch and wait atmosphere at both the state and federal levels, and expressed sincere thanks to the fiscal teams for their hard work during an unusually challenging year.

Vice Chancellor Dunn provided a brief presentation and touched on the following topics:

- Budget assumptions were discussed
- No final data was currently available for FY ending 2020.
- Funding deferrals were estimated, and with federal relief CCCD would need to borrow \$20 million and without federal relief approximately \$40 million.
- Funding reductions for 2021 were estimated at approximately 2%.
- Benefits renewal increases estimated to be 1.3% or approximately \$600,000.
- Pension data net reduction across PERS and STRS approximately \$100,000.
- July 14, 2020 the Trump Administration rescinded an order for international students to leave the country.
- A follow up relief package was expected.
- The final budget would be presented at the second board meeting in October 2020.

Dr. Dunn responded to Trustees' questions. Trustee Hornbuckle requested the Chancellor provide the Board with an update on budget savings suggestions.
