5. Overview of Governor's Budget Proposal for Fiscal Year 13-14

Mr. Dunn provided the members of the Committee with an overview of the January 10th Governor's Budget Proposal for Fiscal Year 13-14.

He shared that he and Ms. Thompson would fly to Sacramento to learn more about the Governor's Proposal.

Mr. Dunn shared that the planned changes included the transition of adult education and apprenticeships to community colleges.

Trustee Moreno summarized that the outcome from census based would make a difference in the CTE programs, and the ninety unit issue could impact students. Trustee Grant shared his concern that it may be hard to enforce the ninety unit rule and Dr. Serban proposed procedures for enforcement. She also clarified that the unit maximum in the Student Success Act was 100 units within the District.

6. CCCT CTE Task Force Update

Dr. Serban provided the members of the CTE Committee with an update on the CTE Task Force activities.

Trustee Moreno explained the process of collecting data from the various campuses and the development of the differential funding analysis. He also shared that he would present the findings to the members of the CCCT at the January Meeting in Sacramento.
