## 6. Results of the Survey of Students Leaving or Completing CTE Programs at Coast Colleges

Dr. Serban provided the Committee with three surveys of the results of students leaving or completing CTE programs at the Coast Colleges. She also included statewide summary community results. These surveys included individuals that were enrolled in 2010-2011 CTE Programs and individuals that were not enrolled in 2011-2012 because they either earned a certificate, degree or 9 units in the CTE program at the respective college. She pointed out that an interesting part of the survey was the number of people employed full-time before they were enrolled in the respective college, and how many were working full-time afterwards. In the survey, Coastline showed that 80% of the respondents were working full-time before enrolling and approximately 83% were working full-time after being enrolled in the respective certificate program. The percentages were much lower for Golden West College and Orange Coast College which indicated that students enrolled at Golden West College and Orange Coast College were traditional students.

a) Methodology of the Summary and Long Term Plan if Appropriate

Mr. Moreno indicated he hoped Mr. Thompson would put together a method of tracking student success and work closely with the college presidents.

Dr. Serban presented the State Chancellor's Office Salary Surfer website that enables students to see median salaries that could be earned with any community college certificate or major program.

Dr. Serban updated the Committee on all of the grants that Coast Colleges have received, have applied for, and those currently pending. Dr. Serban indicated that she would be working with the colleges to ensure that all grants are updated on the chart presented.

#### 9. Information on Number of Graduates from CTE Programs

Mr. Thompson presented a preliminary report that provided a brief description of the number of CTE degrees and certificates awarded in the District. The report emphasized the number of degrees and certificates awarded during summer 2008 through Spring 2012.

#### 10. Review/Status Updates on the Campuses

Mr. Benoit announced that Orange Coast College had hired Mr. Cassell Von Lawson as the new Director of Career Services.

## 11. Impact of Governor's Approved State Budget on Community College CTE Programs

Dr. Serban stated that the funding for CTE grants was very strong from the state although the application process had changed significantly. She added that Coast Colleges would continue to apply for grants in the future.
