1. Call to Order

Trustee Patterson called the meeting to order at 10:08 a.m.

2. Roll Call

3. Opportunity for Public Comment

4. Approval of Minutes: Meeting of June 21, 2012

5. State Update

a. Legislative Report on priority bills

Committee Members and Ms. Fenton discussed bills that are currently active or dead. Ms. Fenton informed the Committee that SB 1466 made it to the Assembly Appropriations but that SB 1356 did not, and they are both needed to be packaged together as a bill in order for it to be implemented. SB 1466 was amended to be independent of the now dead bill SB 1356, and is going to the Assembly floor as a single bill.

Mr. Patterson and the Committee requested that Ms. Fenton provide information regarding the legal concerns from the attorney general office for bill AB 2164.

The Committee Members discussed bill AB 2307(Butler): Classified school employees and decided to add it to the watch list. The Committee Members continued with SB 1280 (Pavley): Best Value competitive bid and decided to add it to the September 5, 2012 Board Agenda so that the whole Board can consider it.

On a motion by Trustee Patterson and seconded by Trustee Prinsky, the Committee voted to do support letter of SB 1280 (Pavley) and SB 1509 and to add it to the September 5, 2012 Board Agenda so that the entire Board can consider them.

b. Orange County Community College Legislative Task Force and Veterans bill

Townsend Public Affairs will be staffing the Orange County Community College Legislative Task Force, the first meeting is on September 6, 2012. The three state bills that they are following on behalf of the task force are AB 2478 (Hayashi), AB 2133 (Blumenfield), and AB 2462 (Block).

c. Board of Governors enrollment priority regulations

Ms. Setoudeh updated the committee on the Board of Governors enrollment priority regulations. If the Board of Governors adopts the enrollment priority, the District would be required to implement these changes fully by Fall 2014.

d. AB 852

Ms. Fenton provided the Committee with an overview on AB 852 Public postsecondary education: community college: temporary faculty.

On a motion by Mr. Patterson and seconded by Dr. Prinsky, the Committee voted to authorize the chair of the Legislative Committee to address a letter of concerns, consequences, and burdens that AB 852 will place on our District.

e. Pension Reform Proposals being considered by the State Legislature

Ms. Fenton and the Committee discussed the Pension reform proposals being considered by the State Legislature and reviewed the Governor's twelve-point pension reform plan document that Townsend Affairs provided.

6. Federal Update

a. Budget

i. Pell Grants

Ms. Fenton reviewed the Overview of Senate LHHS Budget proposal presenting the committee the Pell grant reform. Townsend Public Affairs suggested that the committee support the increase of the maximum Pell grant award to \$5,635 and that the committee oppose the elimination of room and Board benefits for students enrolled exclusively in Distance Education.

ii. Financial Aid regulation

Ms. Setoudeh mentioned the limit on duration of a student borrower's in-school interest subsidy to 150 percent of the normal time required to complete the educational program as one way that the U.S. Senate Appropriations Committee believes they can save 3.5 billion dollars in the upcoming year.

- c. Grants advocacy

Ms. Setoudeh provided the Committee with some grant opportunities through the Department of Education. She mentioned the Hispanic-Serving Institutions (HIS) grant, along with a new program that is for low-income single parents.
