- Education/Higher Education budget resolutions and proposals had not passed at this time
- The Senate had moved forward on the Water Bill, Veterans' Affairs and Military Construction
- \$100 million initiative for Community Colleges nationwide
  - A possible grant program that would provide more funding to Community Colleges for students to pursue certificates or technical degrees.
  - Department of Labor would release information regarding application guidelines.
