4. Authorization under Brown Act, Government Code § 54953(e), for Conducting DSC Meetings Remotely Due to the COVID-19 Emergency Because Meeting in Person Would Present Imminent Risks to the Health or Safety of Attendees

Lalo Velasco moved to implement Zoom meetings for all future DSC meetings for the remainder of the year. Roseleen Gerges seconded. No discussion. Approved unanimously.

5. Guest Speaker – Erik Fallis, District Director Public Affairs, Marketing and Foundation

Mr. Fallis gave an overview of the functions of his department and gave a helpful presentation on how to write resolutions and answered students' questions.

Lalo Velasco gave a presentation of a proposed safe parking initiative. John Bruning established a Task Force consisting of a representative from each college. Faith Luu from Golden West College and Brook Mai Ha from Orange Coast College volunteered to serve with Lalo. The Task Force was charged to return this item to the February 10, 2023 DSC meeting to include the following information:

- Costs
- Available grants
- How the District would prevent non-students from utilizing these services
- How the District could limit its liability

It was suggested that the Task Force reach out to all constituency groups on the campuses to start conversations and obtain feedback and suggestions.

RESOLUTION

Coast Community College District Student Council Resolution Regarding Disability Inclusion

December 2022

WHEREAS, Student Government is the representative and the unified voice that affirms students' concerns at Coastline Community College (Coastline), Golden West College (GWC), and Orange Coast College (OCC), each being a part of the Coast Community College District (CCCD) and the greater California Community College (CCC) system;

WHEREAS, The Americans with Disabilities Act (ADA) defines disability as a physical or mental impairment that substantially limits one or more major life activities [1];

WHEREAS, Students with disabilities are a historically underrepresented and less-supported student group due to the higher education system's barriers to access [2], and disabled students in higher education experience greater social exclusion, lack of support, adverse social attitudes and stigmas, and lack of inclusive understanding of the disability experience [3];

WHEREAS, CCCD has a responsibility to provide equal opportunities and reduce equity gaps among underrepresented student groups in accordance with the CCC's Vision for Success [4] and CCCD Board Policy AP 5140 [5], and Coastline College, Golden West College, and Orange Coast College should continue to dedicate time to build awareness and to celebrate the differences and accomplishments of students with disabilities along with all other students;

WHEREAS, 26% (approximately 1 in 4) of all Americans live with disabilities [6] and 19% (approximately 1 in 5) of undergraduate students overall in America live with a disability [7], and Coastline has served up to 53.36% of all disabled students receiving services from Disabled Students Programs and Services (DSPS) in the CCCD [8];

WHEREAS, Coastline, Golden West College, and Orange Coast College generally do not include disabled student populations in the majority of its minority awareness events, or general Diversity, Equity, and Inclusion (DEI) initiatives, and each college along with CCCD need to continue to identify opportunities to incorporate disabled student populations into their disaggregation of institutional effectiveness metrics with intentionality and in accordance with local, state, and federal data privacy and data security regulations and legislation [9];

NOTWITHSTANDING, Different definitions of disability used by local, state, and federal governments, colleges and college districts, and other constituency groups may conflict with or expand upon the definition provided within the Americans with Disabilities Act;

NOW, THEREFORE, BE IT RESOLVED, that, The Coast District Student Council urges, on the behalf of its disabled constituents, that Coastline College, Golden West College, and Orange Coast College begin hosting ongoing disability cultural and awareness events alongside and with the same strategies and frequency as other cultural events;

RESOLVED, The Coast District Student Council urges Coastline College, Golden West College, and Orange Coast College leadership to work with college faculty members to make disability rights topics mandatory in history and social science classes in order to increase student awareness of disability rights and inclusion, and reduce social exclusion of disabled students;

RESOLVED, The Coast District Student Council urges Coastline College, Golden West College, and Orange Coast College leadership to work with the Coast Community College District (CCCD) leadership to implement widespread equity, inclusion, and disability rights and accessibility training as a part of staff, faculty, and administration professional development;

RESOLVED, The Coast District Student Council urges Coastline College, Golden West College, and Orange Coast College leadership and work groups to track, analyze, and include disabled student data as a priority in their Student Equity and Achievement (SEA) plans and assessment of Disproportionately Impacted (DI) Student Groups in their institutional effectiveness initiatives in order to increase the support disabled students receive and to increase each College's eligibility for disability-focused grants and scholarship funding from state and federal governments.
