5. Guest Speaker Casey Elliott, Vice President, Townsend Public Affairs

- Advocacy firm
 - Offices located from Orange County, Central Valley, Bay areas, Sacramento to Washington DC.
 - \circ $\;$ Federal and state legislation from policy and funding aspect
 - Work with local public agencies, Community Colleges, cities, counties, water etc.
- 12 registered State lobbyist in California and 10 registered lobbyists in Washington DC
- Little over 17 years; started at 4 years old, previously worked at California with Senator Tom Umberg
- Went to UC Davis, senior interned at Assembly desk
- No right or wrong way in entering lobbyist
- Have people skills, and be able to multitask, and a good problem solver

- March 1st fiscal house in order located in DC last year bills (difficult to pass bills)
 - Policy bills discussed up to 2025 to change policy
- Sacramento is starting to get going (2-year of a 2-year cession)
 - Bill Introduce deadline is February 16; 2,500 bills for consideration deadline is August 31 (end of session)
 - State budget is an overriding issue that will impact all policies (i.e. Community Colleges)
 - Cal Grant 2 to Cal Grant 4 is \$5 Million for the state (Cal Grant reform, simpler only 2 applications 1 for CC and 1 4-years)
 - o Student housing want to do but limited in funding
 - 1500 introduced already
 - AB 1818 is introduced (homeless student parking lots); last introduced was 5 years ago
 - AB 1855 (teleconference under Brown Act only for student body not given to Board of Trustees; multi-colleges district)
 - AB 2104 and SB 895: Pilot program for 15 districts BA in nursing for community colleges (BA degrees in nursing was offered 8-9 years ago)
 - Can't overlap with CSU/UC programs
 - Healthcare was on a decline (present day)/shortage of healthcare workers
 - \$60 million dollars were allocated for nursing majors (Governor's budget in theory)
