The BP 2018 has been final through the Chancellor's Cabinet. However, it will still need to be re-number.

AP 2105 has been raised with some concerned by members of the Board.

Ashley gave an update and a quick de-brief of the bills that the DSC AB 13 and SB 290 are now similar. Can give position up to the point the Governor sign it, at any point the DSC can give position on bill that is on the floor. Policy Committee will tailor on specific task such as higher education. Quick update: AB13 pass out of higher education and will be in appropriation next. In past years similar bills have not been past in appropriation, but keep in mind that we should take support in any bill that the DSC support. AB 447 has been though its policy committee. AB 1162, financial aid credit card, will be heard in appropriation. SB 35, energy education Senate Education Committee will be heard in appropriation, has not been calendar yet. SB 440, transfer student for top 25 majors, will be heard in appropriation.
