5. Review, Discuss and Possible Action regarding Potential Districtwide Initiative to Make All Campuses Smoke and Tobacco Free

Guest Speaker: Professor Anna Hanlon, Orange Coast College

Efforts to move to smoke and tobacco free campuses for a healthier campus environment had not yet been successful, and she suggested now would be a good time to advocate for Board Policy.
