  in this effort.
- Tiffany Ruggeri, GWC Communication Studies, will now serve as the ZTC / OER faculty Coordinator. We hit 60% ZTC this term so far! As we work to be at 100% ZTC, Tiffany in collaboration with **Noah Levin** and **Alana Krause** each on special project assignment in OER and ZTC will lead our campus in that direction.
- Instructional Leadership Position Updates:
  - Temporary Interim Director of the Criminal Justice Regional Training Center (Police Academy +),
     Paul Garavan, will start with us on Monday, February 3. Paul has experience teaching with us in the
     GWC Police Academy as well as formerly serving as the Deputy Chief of Police in Tustin.
  - Dean of Math and Science: Danny Johnson has generously agreed to serve in the acting role through this month – thank you Danny! Applications for the permanent position close later this week. We hope to have a permanent Dean in place later this semester. In February, JenKG (VPI) will support the activities of the division in collaboration with Deans Miranda, Brooks, and Martanegara.
  - Dean of Arts and Letters: A Temporary Interim Dean will step in to support this division in February.

   Only about 1/3 of those teaching online in Spring have attended an RSI training to date, which is very concerning. Approximately 50 Spring 2025 course sections will be randomly selected for ACCJC review. The training is 1 hour long, and part-time faculty will be paid. Sign up today!

- Stay tuned for updates on Common Curse Numbering (CCN 1111) and CalGETC (AB 928) updates.
- Looking back at Fall, here is what our faculty and Curriculum Specialist accomplished:
  - 125 total courses were corrected for units and hours alignment
  - 25 associate degrees for transfer (ADT) were revised to meet Cal-CETC requirements all affected GWC degrees have been updated!
  - 7 courses were revised for Phase 1 CCN (Common Course Numbering) all required Phase I courses were aligned – well done!
  - o Generally speaking, 189 courses were revised, and 32 courses were retired.
- Buckle in, Spring is poised to be equally busy.
